#### REPORT

## OF THE BSEC WORKING GROUP ON AGRICULTURE AND AGRO-INDUSTRY AND THE MEETING OF HIGH-LEVEL OFFICIALS OF THE MINISTRIES OF AGRICULTURE OF THE BSEC MEMBER STATES

(Istanbul, 16-17 December 2003)

- 1. The Meeting of the Working Group on Agriculture and Agro-Industry/the Meeting of the High-level Officials of the Ministries of Agriculture of the BSEC Member States and the Concluding Workshop of the BSEC UN FAO Project on Institutional Strengthening to Facilitate Inter- and Intra-Regional Agricultural Trade among BSEC Member States was held in Istanbul at the BSEC Premises on 16-17 December 2003, according to the relevant resolution of the Meeting of the Council of Ministers of Foreign Affairs of the BSEC Member States, held in Baky, Republic of Azerbaijan on 31 October 2003.
- 2. The Meeting was co-chaired by Mr. Elnur ALIYEV, Desk Officer on the BSEC issues, Department for Economic Cooperation and Development, Ministry of Foreign Affairs of the Republic of Azerbaijan, Dr. Holger KRAY, Project Team Leader and Mr. Bernhard d'AVIS, the Project Backstopping Officer.

- 8. In line with the outcome of the Second Workshop of the Project, and based on the relevant contributions of National and International Experts, the Draft Final Main Report of the Project on "Institutional Strengthening to Facilitate Intra- and Inter- Regional Agricultural Trade of the BSEC Member States", with Policy Recommendations was presented by the Project Team Leader, Dr. Holger KRAY.
- 9. The High-level Officials and experts discussed the Draft Final Main Report and presented their comments of technical, analytical and informative character. It was agreed that the Project Team Leader will present the revised Final Main Report to the BSEC PERMIS by 20 January 2004, incorporating all the relevant alterations.
- 10. The High-level Officials and experts expressed their appreciations to the Project Team Leader, Dr. Holger KRAY for an outstanding Presentation and highly valued his efforts in preparing the Draft Final Main Report of the Project.

### <u>CONSIDERATION AND ADOPTION OF THE POLICY RECOMMENDATIONS OF</u> THE BSEC-FAO PROJECT

- 11. The Participants of the Meeting discussed, amended and adopted the Policy Recommendations of the Project. The Policy Recommendations as adopted are attached to the Report as Annex III.
- 12. The High-level Officials further requested the Council to consider the Policy Recommendations of the Project with a view of their endorsement. They also requested the UN FAO Team to consider the possibility of participation of the International Team Leader to the forthcoming Meeting of the Committee of Senior Officials, with a view to present the recommendation on establishing of a BSEC Trade Facilitation Body.
- 13. The High-level Officials also noted the importance of the continuation of the established cooperation between the BSEC and UN FAO.
- 14. The High-level Officials also expressed their appreciation to Messrs. Bernhard d'AVIS, former and Mr. David SEDIK, current Chiefs REUP, UN FAO and Dr. Holger KRAY, the International Team Leader of the Project for their personal efforts in successful implementation of the Project.
