#### REPORT OF THE MEETING OF THE BSEC WORKING GROUP ON COOPERATION IN EMERGENCY ASSISTANCE AND LIAISON OFFICERS OF THE BSEC NETWORK ON EMERGENCY ASSISTANCE

## BSEC Headquarters, 12 April 2017

1. The Meeting of the BSEC Working Group on Cooperation in Emergency Assistance and Liaison Officers of the BSEC Network on Emergency Assistance was held at the BSEC Headquarters on 12 April 2017.

The Member States are invited to come up with project proposals on issues promoting the activities of the Network Liaison Officers on Emergency Assistance, as envisaged in the Modalities of Work for this Network.
