## REPORT OF THE MEETING OF THE BSEC AD HOC WORKING GROUP OF EXPERTS IN SEISMIC RISK

### **BSEC Headquarters, 2 October 2015**

- 1. The Meeting of the BSEC Ad Hoc Working Group of Experts in Seismic Risk was held at the BSEC Headquarters, on 2 October 2015.
- 2. The Meeting was chaired by Mrs. Brandusa PREDESCU, Special Representative of the Romanian Chairmanship-in-Office of the Organization of BSEC, Ministry of Foreign Affairs of Romania.

- 10. The participants agreed that the priorities relevant for the activities of the Ad Hoc Working Group in Seismic Risk should be incorporated in its Plan of Action.
- 11. The Ad Hoc Working Group invited the Member States to submit concrete project proposals in the area of seismic risk cooperation based on the priority goals of the BSEC Economic Agenda 2012.

- 12. The Participants took note of the presentation made by the delegation of the Republic of Turkey, in its capacity of Country-Coordinator on the evaluation of the capacity and the need assessment of the Ad Hoc Working Group of Experts in Seismic Risk. The Ad Hoc Working Group expressed its appreciation to the Disaster and Emergency Management Presidency of the Republic of Turkey (AFAD) for preparing the appropriate Questionnaire in order to evaluate the current activities, challenges and areas of interest in the field of earthquake studies within the BSEC Member States.

14. The Ad Hoc Working Group invited the Member States which have not yet done so, to provide completed Questionnaire through BSEC PERMIS for dissemination to the Member States.

- 16. The Ad Hoc Working Group considered the Plan of Action to remain open for possible further proposals from the Member States.
