## REPORT OF THE MEETING OF THE MINISTERS OF ENERGY OF THE BSEC MEMBER STATES

## Alexandroupolis, 4 March 2005

- 1. The Meeting of the Ministers of Energy of the BSEC Member States was held in Alexandroupolis, Greece, on 4 March 2005.
- 2. The Meeting was chaired by H.E. Mr. Dimitris SIOUFAS, Minister of Development of the Hellenic Republic.

- 10. The draft agenda of the Meeting was discussed and adopted. The agenda, as adopted by the Heads of the Delegations, is attached as Annex II.
- 11. The Heads of Delegations delivered their general statements and discussed on the Agenda items.
- 12. The Participants of the Meeting adopted the "Alexandroupolis Declaration on Energy Cooperation in the BSEC Region". The Declaration is attached as Annex III.

The Participants expressed deep gratitude to the Government of the Hellenic Republic for its successful BSEC Chairmanship-in-office and its contribution to the promotion of the BSEC goals as well as for the hospitality extended to the delegations and the excellent organization of the Meeting in Alexandroupolis.
- 14. The Participants adopted the Report of the Meeting and decided to present it to the Twelfth Council of the Ministers of Foreign Affairs of the BSEC Member States to be held in Komotini, Hellenic Republic, on 23 April 2005.
