BSEC Headquarters, 25-26 May 2016

- 1. The Meeting of the BSEC Working Group on Energy was held at the BSEC Headquarters, on 25-26 May 2016.

- 11. The delegation of the Republic of Turkey made a presentation on the recent developments in the electricity market of Turkey.

AGENDA ITEM 5: GREEN ENERGY

- 12. The participants took note of the *draft Green Energy Strategy Paper*, updated by the Russian Federation as the Country-Coordinator of the Working Group. The document is attached as **Annex IV** to the Report.
- 13. The Working Group agreed to consider the document at its next Meeting and the Member States are invited to provide their proposals and amendments to the text **by 1 September 2016**.
- 14. The Working Group invited the Member States to nominate **by 1 September 2016** national governmental bodies, academia and research institutions, as well as companies active in the area of Green Energy to participate in the BSEC Green Energy Network of Cooperation and in particular to confirm their agreement with the inclusion in the Network of the research institutes and universities which expressed their interest for participating in the Network in their direct contacts with KEPA.

- 15. The Working Group took note of the information provided by the Republic of Armenia on renewable energy resources of Armenia. The document "Renewable Energy Roadmap for Armenia" prepared by the Ministry of Energy and Natural Resources of the Republic of Armenia was circulated to the Member States by the BSEC PERMIS Note BS/INFO.2016.0245 dated 17 May 2016.
- 16. The Member States are invited to provide **by 1 September 2016** their proposals on developing Renewable energy resource mapping for the BSEC Region.

AGENDA ITEM 6: COOPERATION OF THE BSEC MEMBER STATES IN EXPLORATION AND EXTRACTION OF HYDROCARBON RESOURCES OF THE BLACK SEA

17. The delegation of the Republic of Turkey presented information and comments on hydrocarbon exploration activities and oil prices.

- 20. The delegation of the Republic of Armenia informed the participants of the interest of an Energy Research Institute of Armenia to be involved in the process of developing electrical interconnection in the Black Sea region.
- 21. The delegation of Georgia informed the participants of the process of developing electrical interconnection with neighbour countries.
