REPORT OF THE MEETING OF THE MINISTERS IN CHARGE OF ENVIRONMENTAL PROTECTION OF THE BSEC MEMBER STATES

Belgrade, 23 April 2012

- 1. The Meeting of the Ministers in Charge of Environmental Protection of the Member States of the Organization of the Black Sea Economic Cooperation (BSEC) was held in Belgrade on 23 April 2012.
- 2. The Meeting was chaired by H.E. Mr. Prof. Ivica RADOVIĆ, State Secretary, The Ministry of Environment, Mining and Spatial Planning of the Republic of Serbia.
