Bucharest, 31 May 2011

- 1. The Meeting of the Ministers in Charge of Environmental Protection of the Member States of the Organization of the Black Sea Economic Cooperation (BSEC) was held in Bucharest on 31 May 2011. It was preceded by the Meeting of the BSEC Working Group on Environmental Protection on 30 May 2011.
- 2. The Meeting was chaired by H.E. Mr. Lazslo BORBELY, Minister of Environment and Forest of Romania.
