THE HIGH-LEVEL CONFERENCE ON INFORMATION AND COMMUNICATION TECHNOLOGIES OF THE BSEC MEMBER STATES

Yerevan, 5 October 2013

REPORT

- 1. The High-Level Conference on Information and Communication Technologies of the Organization of the Black Sea Economic Cooperation (BSEC) was held in Yerevan, Republic of Armenia, on 5 October 2013. The Conference was preceded by the Meeting of the BSEC Working Group on Information and Communication Technologies held at the BSEC Headquarters in Istanbul, on 25 September 2013.

- 10. Mr. Vahagn LALAYAN, Head of Investment Policy Department, Ministry of Economy of the Republic of Armenia, delivered a presentation on the Armenian Free Economic Zones Program.

Mr. Michael VARDANIAN, Permanent Representative of the Republic of Armenia to the Organization of BSEC, shared the results of the last Meeting of the BSEC Working Group on Information and Communication Technologies (BSEC Headquarters, Istanbul, 25 September 2013) with the participants of the High-Level Conference.
- 12. The participants appreciated the activities of the Working Group and took note of the outcomes of its last Meeting.
- 13. The participants also encouraged the Working Group on ICT to undertake further efforts in developing prospects of cooperation with the BSEC Related Bodies, Observers, Sectoral Dialogue Partners, relevant international organizations and other interested partners.
