Sofia, 9 April 2010

- 1. The Meeting of the Ministers Responsible for Science and Technology of the BSEC Member States was held in Sofia on 9 April 2010.
- 2. The Meeting was chaired by Ms. Petya EFTIMOVA, Deputy Minister, Ministry of Education, Youth and Science of the Republic of Bulgaria.
