



REPORT OF THE MEETING OF THE MINISTERS RESPONSIBLE FOR SCIENCE AND TECHNOLOGY OF THE BSEC MEMBER STATES

Athens, 28 September 2005

- 1. The Meeting of the Ministers Responsible for Science and Technology of the BSEC Member States was held in Athens, on 28 September 2005.
- 2. The Meeting was chaired by Deputy Minister of Development of the Hellenic Republic, H.E. Mr. Yannis PAPATHANASSIOU.

- 12. The Ministers and Head of Delegations agreed to forward the Declaration and the Action Plan for endorsement to the forthcoming Meeting of the Council of Ministers of Foreign Affairs of the BSEC Member States (Chisinau, 28 October 2005).
- 13. The Ministers and Head of Delegations expressed their gratitude to the Hellenic Ministry of Development and the ICBSS for their hospitality and excellent arrangements for the Meeting, as well as to the European Commission for supporting the organisation of this series of Meetings.
