# REPORT OF THE STEERING COMMITTEE ON THE DEVELOPMENT OF THE BLACK SEA RING HIGHWAY

#### **Fifth Meeting**

#### Istanbul, 31 March 2011

- 1. The Fifth Meeting of the Steering Committee (SC) on the Development of the Black Sea Ring Highway (BSRH) was held in Istanbul, on 31 March 2011.
- 2. The Meeting was chaired by Mr. Stefan IVANOV POPOV, Chief Expert of the National Transport Policy Directorate of the Ministry of Transport, Information, Technology and Communications of the Republic of Bulgaria.
- 3. The Meeting was attended by the representatives of the following Members of the Steering Committee of the BSRH:

#### **ADOPTION OF THE AGENDA**

#### APPOINTMENT OF PENDING NATIONAL COORDINATORS

7. The Steering Committee requested the countries which have not yet done so, to inform the JPTS about the nomination of their national coordinators. The list of National Coordinators is attached as Annex III.

# ELABORATION OF THE MAIN ROUTE OF THE BSRH AND ITS CONNECTIONS

- 8. The Member States gave their positions about the main BSRH route passing through their territories. The positions are reflected in the map attached as Annex IV and described in the relevant technical report to be circulated by JPTS to all Member States.
- 9. Ukraine suggested to develop the main route in two directions:
  - a) Odessa- Ukrainian Romanian border (Orlivka Isaccea) –(going to Constanta- Bucharest) and
  - b) Odessa- going to Tiraspol- Chisinau and Bucharest
- 10. The Steering Committee has noted the intention of Ukraine to start negotiations with Romania and Moldova regarding the above mentioned proposal. Ukraine recalled the proposal for the connection between Odessa and the border of Moldova anticipating the results of the mentioned forthcoming negotiations.
- 11. The Presidency has called upon the Member States to confirm their approval of the final version of the main route before the next Meeting of the Steering Committee.

- 12. The Steering Committee took note of the presentation by the International Road Transport Union (IRU) on the Model Highway Initiative which is attached as Annex V.
