Sochi, the Russian Federation, 22 June 2016

- 1. The Joint Meeting of the BSEC Working Groups on Culture and on Cooperation in Tourism, convened as an expert meeting to prepare the Conference of the Ministers in charge of Culture and Tourism of the BSEC Member States (Sochi, 23 June 2016), was held in Sochi, on 22 June 2016.
